#### TONIX PHARMACEUTICALS ANNOUNCES FULL EXERCISE AND CLOSING OF UNDERWRITERS' OVER-ALLOTMENT OPTION

NEW YORK, April 13, 2017 (GLOBE NEWSWIRE) — Tonix Pharmaceuticals Holding Corp. (TNXP) ("Tonix"), a company that is developing innovative pharmaceutical products to address public health challenges, today announced that the underwriters of Tonix's previously announced public offering that initially closed on April 4, 2017, have purchased an additional 270,000 shares of Tonix's common stock at a price of \$4.45 per share, before deducting the underwriting discount, in connection with the exercise in full of their over-allotment option. Tonix has now sold a total of 2,070,000 shares of its common stock in connection with the offering, with total gross proceeds of \$9,211,500, before deducting underwriting discounts and commissions and other estimated offering expenses payable by Tonix.

Aegis Capital Corp. acted as the sole book-running manager for the offering and Dawson James Securities, Inc. acted as a co-manager.

The shares described above were offered pursuant to an effective shelf registration statement on Form S-3 (No. 333-197824) previously filed with the U.S. Securities and Exchange Commission (the "SEC"). Tonix is developing innovative pharmaceutical products to address public health challenges. TNX-102 SL is in Phase 3 development and has been granted Breakthrough Therapy designation by the FDA for the treatment of PTSD. PTSD is a serious condition characterized by chronic disability, inadequate treatment options especially for military-related PTSD, and an overall high utilization of healthcare services that contributes to significant economic burdens. The Protectic<sup>TM</sup> protective eutectic and Angstro-Technology<sup>TM</sup> formulation are essential elements of the proprietary TNX-102 SL composition for which a Notice of Allowance has been issued by the U.S. Patent and Trademark Office. Other development efforts include TNX-601 (tianeptine oxalate), a clinical candidate at Pre-IND (Investigational New Drug) application stage, designed for daytime use for the treatment of PTSD, and TNX-801, a potential smallpox-preventing vaccine based on a live synthetic version of horsepox virus.
